DESIGNATED REALTOR MEMBERSHIP ADMITTANCE RULES

- 1. The Broker applicant's qualifications are based upon their reputation, financial responsibility, competence, business ethics and adherence to Local, State, and National regulations.
- 2. Applicants for Active (REALTOR®) membership are those engaged in selling, renting, managing, appraising and/or financing of Real Estate and who have a New York State issued broker's license.
- 3. It is mandatory that an applicant's name be published in the Association Newsletter.
- 4. Incomplete applications will not be accepted.
- 5. An applicant agrees that an appointment be made with the General Manager to familiarize himself/herself with the BNAR/WNYREIS Rules and Regulations.
- 6. The applicant is to supply a list of all licensees with their firm.
- 7. The REALTOR® member is responsible for the education of each of his/her licensed salesperson. Remember that ALL licensed salesperson must complete 22 ½ hours of a State-approved Continuing Education Course every two years prior to expiration of their license. (The Association sponsors such courses).
